

CHARTER TERMS AND CONDITIONS FLIGHT AGREEMENT

This quote is based upon aircraft and crew availability at time of request. Use of aircraft is pending owner release. Also, charter quote is an estimate. Extra costs may occur if there are changes to the flight schedule. Landing, ramp, hangar, de-icing, customs, ground transportation, crew expenses, wait time and international handling fees are estimates; actual costs will be billed after the trip is completed.

PRICES, PAYMENTS, AND CANCELLATION: Flight time and fuel surcharge amounts quoted herein are accurate for the itinerary listed and valid for the duration of the trip providing it does not alter. All expenses are estimates; therefore, the final invoice may vary. Prepayment of the quoted amount required via credit card or wire transfer (ACH) prior to the trip being dispatched. If the final bill is less than the prepaid amount, Aviation Services Group, Inc. will issue a refund via check upon completion of the trip. If the final bill is more, the Charter customer is responsible for paying the difference upon receipt of the adjusted invoice. The Charter customer agrees that in the event a booked flight, or any part of that trip, is canceled within 24 hours for domestic and 48 hours for international; Charter customer shall pay to Aviation Services Group, Inc. upon receipt of invoice: a **\$500** cancellation fee in addition to any amounts (permit fees, crewing, flight planning, scheduling, insurance, hotel cancellation, catering, etc.) which may be due by reason of partial completion and/or cancellation of the original itinerary including the return of aircraft and crew to its base.

REQUIRED DOCUMENTATION: Per Transportation Security Administration (TSA) regulations, all passengers, who are **18** years or older, must present a valid government issued photo ID to a designated crew member and be cleared by TSA prior to boarding. If the ID is expired, the ID is not valid, and the person will not be allowed to board the aircraft. To avoid delays, please provide full passenger names as listed on their current government issued photo ID, date of birth, gender, and weights. Children under **18** are not required to have an ID when accompanied by a parent/guardian; however, full legal names, gender, and weights are required. For international flights, children under **18** traveling with a single parent/guardian must possess notarized travel authorization from the non-traveling parent/guardian. Please notify all passengers of these requirements.

ITINERARY CHANGES AND TRANSMITTAL OF CHANGES: Itinerary changes are permitted, but subject to aircraft and crew availability as well as subject to price adjustment. Notification of changes and/or cancellations must be in writing and transmitted by text to **(205)966-6475** and **(205)936-7292** AND emailed to rmasters@flyasg.com and bingram@flyasg.com within the cancellation period listed above.

PARTIAL COMPLETION OF FLIGHTS: In the event of a mechanical interruption, Aviation Services Group, Inc. will make every effort to provide a substitute aircraft at the quoted cost; however, in the event the quoted aircraft cannot be repaired for the requested departure date/time, Aviation Services Group, Inc. will provide alternate aircraft options that the Charter customer may accept or reject at his/her sole discretion. Charter customer will bear any cost differences associated with any accepted substitute aircraft.

If a flight does not reach its destination due to weather, charges apply to any destination reached and return flight of the aircraft and crew (with or without passengers) to home base.
